**Region VI consists of New Jersey, Pennsylvania, Delaware,
Maryland and Washington DC chapters.**

New Website: Our new website is currently being built and is on-track for completion this year! The phase 1 launch is expected in the Fall of 2023 with a phase 2 launch in the first half of 2024. The website changes will include, among other things:

- * Increase AI brand reputation and awareness
- * Standardize the look and feel across sites by utilizing a content model for consistent, uniform presentation
- * Improve customer experience with a responsive design that renders across size and scale of devices
- * Utilize a consistent taxonomy to deliver content using terms that are relevant to visitors
- * Improve overall usability and reduce complexity of navigation

This is part of the Boards' larger long-term strategic plan to modernize technology. This also includes a rebranding effort to ensure consistent AI branding and messaging. More information relating to the rebranding effort will be forthcoming soon.

AI PAREA: This year, the Appraisal Institute will launch its Practical Applications of Real Estate Appraisal (AI PAREA) program. Modules for both licensed and certified residential will assist aspiring appraisers in their pursuit of licensing and will also assist in removing barriers to entry into the profession. Approval from the AQB for the licensed residential path was received on May 18.

CEO Search: Last November, an announcement was sent to membership that our CEO of many years, Jim Amorin, MAI, SRA, AI-GRS, put in his 90-day notice. Our Acting CEO is Beata Swacha, who also serves as our CFO. A CEO Search Project Team led by Chair Jeffrey Enright, MAI, SRA, AI-GRS, and Vice Chair Misty K. Ray, MAI, AI-GRS, has been created with a charge to identify and recommend to the Board of Directors up to three candidates to serve as Appraisal Institute CEO.

Residential Appraiser Committee: The Board voted to amend Regulation No. 7 to establish a Residential Appraiser Committee. President Steinley appointed Adam B. Johnston, SRA, AI-RRS, to chair this committee and Maria A. Nucci, SRA, AI-RRS, as vice chair.

National Office Move: Build-out of the new, smaller but more efficient office space at our same location is progressing with a move scheduled for this year.

University Relations: Led by Ryan Zink, MAI, the University Relations Committee is launching a pilot program in August designed to target 12 Universities. The purpose of this initiative is to reach out to students, faculty, and administrators at institutions of higher learning in order to promote and enhance awareness of the Appraisal Institute as a leader in the profession, and opportunities in the valuation profession.

DEI Implementation: In August of 2022 the Board approved a DEI (Diversity, Equity, and Inclusion) plan. Implementation of this plan is well underway.

AI Board of Directors Takes Key Actions During May Meeting: Following are some important updates from the latest Board of Directors meeting, held May 11-12, in Chicago.

After considering comments received from AI Professionals, the Board voted to adopt amendments to AI Bylaws and Regulation Nos. 7, 8 and 9 regarding the continuing education program requirement for service.

The Board also:

- Voted to establish a Region Project Team to review Regulation No. 9.
- Voted to amend the criteria for the Women's Initiative SPOTLIGHT Award.
- Voted for the Admissions and Designation Qualifications Committee to review annual income eligibility for Practicing Semi-Retired Designated Member status.
- Voted to provide an electronic copy of Robert's Rules of Order to third regional directors.
- Voted to approve Michael Strong, SRA, to serve a third consecutive term as Alaska Chapter president in 2024.
- Directed to expose for a second time proposed amendments to the Bylaws and Regulation No. 4 regarding Life Membership with additional background and rationale.
- Directed to expose for comment proposed amendments to Regulation Nos. 2 and 3 regarding Residential and Residential Review Experience Requirements.
- Directed to expose for comment proposed amendments to Regulation No. 10 related to Designated Member CE Cycles.
- Approved the appointment of Lindsey M. Willis, MAI, AI-GRS, to the Education Committee for a term running through Dec. 31, 2023.

The Appraisal Institute also held its Statutory Annual Membership Meeting.

AI Board to Consider 2 Candidates for 2024 Vice President in August: The Appraisal Institute Board of Directors announced June 14 that they will consider two candidates for the position of 2024 vice president at its Aug. 10-11 meeting in Schaumburg, Illinois. The two nominees are (in alphabetical order) Michael J. Acquaro-Mignogna, MAI, SRA, AI-GRS; and Claire M. Aufrance, MAI, SRA

Appraisal Diversity Initiative

Appraisal Institute Offers Numerous Opportunities for Aspiring Appraisers

The Appraisal Institute has several existing programs concentrating on attracting new entrants to the profession, including the [Appraiser Diversity Initiative](#) with Fannie Mae, Freddie Mac and the National Urban League, along with the Minorities and Women Course Scholarship Program from the Appraisal Institute Education and Relief Foundation.

The Appraisal Institute Education and Relief Foundation has committed \$150,000 over three years to the [Appraiser Diversity Initiative](#). The scholarships cover the three entry level courses required of appraisers and winners are matched with advisers who help them through the education and credentialing process. The AIERF also offers scholarships for existing valuation professionals.

Additionally, The Appraisal Foundation's Board of Trustees awarded the Pathway to Success Grant to the Appraisal Institute for the development of a Practical Applications of Real Estate Appraisal program in collaboration with its partners. The competitive grant application was reviewed, scored, and recommended for approval by a team representing Foundation trustees, sponsoring organizations and the Appraiser Qualifications Board.

PAREA is an alternative pathway for aspiring appraisers to gain their required experience hours to become a certified appraiser. Historically, the only option for an appraiser to complete their experience hours was through a supervisor/trainee model that requires the aspiring appraiser to find their own supervisor. PAREA is currently accepted in more than 30 states, and that number is set to increase as more states adopt this alternative pathway. [Learn more about PAREA here.](#)

Appraisal Institute PAREA Program Receives Approval from Appraiser Qualifications Board

CHICAGO (May 18, 2023) – The Appraisal Institute announced today that the Appraiser Qualifications Board has provided approval of AI's Practical Applications of Real Estate Appraisal program for the licensed residential path.

The Appraisal Foundation's Board of Trustees awarded the Pathway to Success Grant to the Appraisal Institute to assist with the development of the PAREA program. The Pathway to Success Conditional Grant is designed to open up the appraisal profession to a new generation of appraisers and stipulates that participant priority be given to veterans, minorities and those in designated rural areas. AI was awarded the full grant amount of \$500,000 to build its AI PAREA program in collaboration with its partners. AI committed more than \$2 million toward AI PAREA.

PAREA, which is an online program, is an alternative pathway for aspiring appraisers to gain their required experience hours to become a licensed or certified appraiser. Historically, the only option for an appraiser to complete their experience hours was through a supervisor/trainee model that requires the aspiring appraiser to find their own supervisor. PAREA is currently accepted in 43 states, and that number is likely to increase as more states adopt this alternative pathway.

Key elements of AI PAREA include:

- Participants will be supported throughout the program by mentors who are Appraisal Institute Designated Members and full-time employees of the organization. The Appraisal Institute specifies rigorous requirements for Designated membership regarding experience, education and moral character and those individuals demonstrate the highest standards of education and ethics.
- AI PAREA participants will have access to the organization's 66 chapters to enhance networking opportunities and connect with appraisers who can potentially help participants become geographically competent, meaning that participants can learn about the specifics of local markets from appraisers with that knowledge and experience.
- In addition to the basic specification of three Uniform Standards of Professional Appraisal Practice (USPAP)-compliant reports established for PAREA programs by the AQB, AI PAREA features an additional 10 practice assignments and reports. The assignments are consistent for all participants and include a variety of complexity and property types to reinforce important appraisal concepts and skills.
- The assignments that are part of AI PAREA are developed by an organization with a 90-plus-year history of creating best-in-class education, publications and other appraisal products.
- AI PAREA participants have access to a knowledge center that includes a variety of resources that appraisers use every day including forms software and a multiple listing service (MLS).

"The AQB's approval of AI PAREA for the licensed residential path is a significant milestone for our organization and the entire valuation profession," said Appraisal Institute President Craig Steinley, MAI, SRA, AI-GRS, AI-RRS. "This program will create many opportunities for aspiring appraisers who might not currently have a pathway into the profession."

"The Foundation is so pleased to see the first PAREA program receive approval from the Appraiser Qualifications Board," said The Appraisal Foundation President David S. Bunton. "The introduction of this program to the marketplace opens a new pathway for aspiring appraisers, and we look forward to welcoming PAREA participants to the appraisal profession."

PAREA will initially welcome select participants during the pilot program phase, who have completed their Qualifying Education and reside in a state which has fully accepted PAREA in lieu of the traditional supervisor/trainee model. AI PAREA is expected to launch broadly and make registration available by September 2023.
